**CERTIFICATE OF AMENDMENT  
OF THE  
CERTIFICATE OF INCORPORATION

**Under Section 803 of the Not-for-Profit Corporation Law**

**FIRST:** The name of the Corporation is: Saratoga County Prosperity Partnership, Inc.

**SECOND:** The certificate of incorporation was filed by the Department of State on: May 29, 2014.

**THIRD:** The law the Corporation was formed under is: Section 1411 of the Not-For-Profit Corporation Law of the State of New York.

**FOURTH:** The Corporation is a corporation as defined in subparagraph (5) of paragraph (a) of Section 102 of the Not-for-Profit Corporation Law.

**FIFTH:** The certificate of incorporation is amended as follows:

Paragraph EIGHTH of the Certificate of Incorporation relating to the dissolution of the corporation is hereby amended to read in its entirety as follows:

EIGHTH: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**SIXTH:** The Secretary of State is designated as agent of the Corporation upon whom process against it may be served. The address to which the Secretary of State shall forward copies of process accepted on behalf of the Corporation is: Saratoga County Prosperity Partnership, Inc., 2911 Route 9, Malta, New York 12020.

**SEVENTH:** The certificate of amendment was authorized by a majority of all members of the Corporation entitled to vote thereon at a meeting of the members and by a majority of all members of the Board of Directors of said Corporation.
