# IDA Public Hearing - Arnoff Moving & Storage

CHAIRMAN SUTTON: Good morning. It is 9:00 a.m. on Thursday, June 9, 2016. I will call to order the public hearing of the Industrial Development Agency of Saratoga County that is being held at the Town of Malta Town Hall, located at 2540 Route 9, Malta, New York. We have received an application from the Arnoff Moving & Storage, Inc. of Albany, a business incorporated in New York State now located at 7 Tivoli Street, Albany, New York on behalf of a limited liability company (the Owner) yet to be formed.

The Company has requested that the Agency undertake a Project consisting of (A) the acquisition of an approximately 39.81 acre parcel of land (the Land) at 1 Racemark Way in the Town of Malta, Saratoga County, New York and (B) the construction of a 20,000 square foot addition (the Addition) to an existing 72,640 square foot facility (the existing Facility, which together with the Addition is to be known as the Facility) on the parcel for use in the Applicant's manufacturing, warehousing, shipping operations and for corporate headquarters (the Facility), and (C) the acquisition and installation of certain machinery and equipment

(the Equipment) in that building together with the Land and the Facility being the Project Facility. The total cost associated with the acquisition, construction and installation of the Project Facility is presently estimated to be \$11,579,630.

The Agency is considering whether to undertake the Project and finance the Project by executing and delivering a mortgage and mortgages (the Mortgage) to secure borrowing or borrowings by the owner (the Loan) in an aggregate principal amount sufficient to finance all or a portion of the cost to acquire, construct and install the Project Facility and the cost of the Loan, with a principal amount currently estimated to be approximately \$7,400,000.

If the undertaking of the Project and execution and delivery of the Mortgage is approved by this Agency then (A), the Project may be granted such exemptions with respect to real property taxes (applicable to the Addition only), mortgage recording tax, and state and local sales tax as are applicable to the commercial services facility as described in the Agency's Uniform Tax Exemption Policy adopted on October 14, 2014, subject to

IDA Public Hearing - Arnoff Moving & Storage 1 deviation as determined by the Agency, (B) the 2 Project Facility will be acquired, constructed, and 3 installed by the Agency and leased or sold by the 4 Agency to the Owner or its designee pursuant to a 5 Project Agreement (the Agreement), and (C) the 6 Applicant and the Owner will be the initial user of 7 the Project Facility. The mortgage will be a 8 special obligation of the Agency payable solely out 9 of certain proceeds of the Agreement and certain 10 other assets of the Agency pledged to the repayment 11 12 of the Loan. I will now ask IDA Counsel Michael J. 13 Toohey if proper legal notices were provided for the 14 public hearing in accordance with the regulations. 15 Mr. Chairman, MR. TOOHEY: 16 publication did take place as required by the 17 18 statute. CHAIRMAN SUTTON: Thank you. Agency 19 members present today are Mary Beth Walsh, Andrea 20
